DETAILED ACTION

1. The present application, filed on or after March 16, 2013, is being examined under the first inventor to file provisions of the AIA.

Allowable Subject Matter

2. Claims 1, 4-5, 8, 10-11 and 13-23 are allowed.

3. The following is an examiner's statement of reasons for allowance: the prior art of record does not teach the claimed subject matter of claims 1, 15 and 19; therefore, claims 1, 15 and 19 are allowable for the reasons pointed out by Applicant's remarks (pp. 9.16).

4. It follows that claims 4-5, 8, 10-11, 13-14, 16-18 and 20-23 are then inherently allowable for depending on an allowable base claim.

5. Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."
